  - A lot grading and drainage plan completed by a qualified person (Professional Engineer or Certified Engineering Technologist “CET”, or other qualifications as deemed appropriate by the Chief Building Official) shall be provided prior to issuing a permit, to allow the installation of an in-ground swimming pool.

**Declaration**
